

An brief introduction to Finsler geometry

Abstract

This work contains a short introduction to Finsler geometry. Special emphasis is put on the Legendre transformation that connects Finsler geometry with symplectic geometry.

Table of symbols in Finsler geometry

For easy reference, the below table lists the basic symbols in Finsler geometry, their definitions (when short enough to list), and their homogeneity (see p. 3). However, it should be pointed out that the quantities and notation in Finsler geometry is far from standardized. Some references (e.g. [Run59]) work with normalized quantities. The present work follows [She01b, She01a].

1 Finsler geometry

Essentially, a Finsler manifold is a manifold M where each tangent space is equipped with a Minkowski norm, that is, a norm that is not necessarily induced by an inner product. (Here, a Minkowski norm has no relation to indefinite inner products.) This norm also induces a canonical inner product. However, in sharp contrast to the Riemannian case, these Finsler-inner products are not parameterized by points of M , but by directions in TM . Thus one can think of a Finsler manifold as a space where the inner product does not only depend on where you are, but also in which direction you are looking. Despite this quite large step away from Riemannian geometry, Finsler geometry contains analogues for many of the natural objects in Riemannian geometry. For example, length, geodesics, curvature, connections, covariant derivative, and structure equations all generalize. However, normal coordinates do not [Run59]. Let us also point out that in Finsler geometry the unit spheres do not need to be ellipsoids.

Finsler geometry is named after Paul Finsler who studied it in his doctoral thesis in 1917. Presently Finsler geometry has found an abundance of applications in both physics and practical applications [KT03, AIM94, Ing96, DC01]. The present presentation follows [She01b, She01a].

Let V be a real finite dimensional vector space, and let $\{e_i\}$ be a basis for V . Furthermore, let $\frac{\partial}{\partial y^i}$ be partial differentiation in the e_i -direction. If $v \in V$, then we denote by v^i the i :th component of v . We also use the *Einstein summing convention* throughout; summation is implicitly implied when the same index appears twice in the same expression. The range of summation will always be $1, \dots, \dim V$. For example, for $v \in V$, $v = v^i e_i$.

Homogeneous functions

A function $f: V \rightarrow \mathbb{R}$ is (positively) *homogeneous of degree* $s \in \mathbb{R}$ (or *s-homogeneous*) if $f(\lambda v) = \lambda^s f(v)$ for all $v \in V$, $\lambda > 0$.

The next proposition will be of great use when manipulating expressions in Finsler geometry. For example, if f is 0-homogeneous, then $\frac{\partial f}{\partial y^i}(y)y^i = 0$.

Proposition 1.1. *Suppose f is smooth and s -homogeneous. Then $\frac{\partial f}{\partial y^i}$ is $(s - 1)$ -homogeneous, and*

$$\frac{\partial f}{\partial y^i}(v)v^i = sf(v), \quad v \in V.$$

The latter claim is known as *Euler's theorem*. The proof is an application of the chain rule.

1.1 Minkowski norms

Definition 1.2. A *Minkowski norm* on V is a function $F: V \rightarrow [0, \infty)$ such that

1. F is smooth on $V \setminus \{0\}$,
2. F is 1-homogeneous,
3. for all $y \in V \setminus \{0\}$, the symmetric bilinear form (see Remark 1.3.1)

$$g_y: V \times V \rightarrow \mathbb{R},$$

$$(u, v) \mapsto \frac{1}{2} \frac{\partial^2 F^2(y + su + tv)}{\partial s \partial t} \Big|_{t=s=0}$$

is positive definite.

Remarks 1.3.

1. The unit sphere of a Minkowski norm on V is called the *indicatrix*.
2. For $u, v \in V$, we have $g_y(u, v) = g_{ij}(y)u^i v^j$ where

$$g_{ij}(y) = \frac{1}{2} \frac{\partial^2 F^2}{\partial y^i \partial y^j}(y). \quad (1)$$

Hence g_y is bilinear.

3. Let $F(x) = |x|$ be the usual Euclidean norm on V induced by a chosen basis. It follows that every finite dimensional vector space has at least one Minkowski norm, namely F .
4. Suppose $u, v \in V, y \in V \setminus \{0\}$. Then

$$g_{\lambda y}(u, v) = g_y(u, v), \quad \lambda > 0,$$

$$g_y(y, u) = \frac{1}{2} \frac{\partial F^2}{\partial y^i}(y)u^i = \frac{1}{2} \frac{\partial F^2(y + tu)}{\partial t} \Big|_{t=0},$$

$$g_y(y, y) = F^2(y).$$

5. $F(y) = 0$ if and only if $y = 0$. Indeed, since F is 1-homogeneous, $F(0) = 2F(0)$, so $F(0) = 0$. On the other hand, if $y \neq 0$, but $F(y) = 0$, then $0 = F^2(y) = g_y(y, y)$, which is impossible since g_y is positive definite.
6. Let $|\cdot|$ be any norm on V . Then $S_E = \{v \in V : |v| = 1\}$ is compact. If $m = \min\{F(v) : v \in S_E\}$, $M = \max\{F(v) : v \in S_E\}$, then

$$m|v| \leq F(v) \leq M|v|, \quad v \in V, \quad (2)$$

and $0 < m \leq M < \infty$.

7. F is continuous on V . Since F is differentiable on $V \setminus \{0\}$, it is also continuous there. That F is continuous at 0 follows by taking a sequence converging to 0 and using the latter estimate in inequality (2).
8. $B = \{v \in V : F(v) \leq 1\}$ is compact. This follows as B is closed and contained in the compact set $\{v \in V : |v| \leq 1/m\}$.
9. Equation (2) implies that any two Finsler norms F, \tilde{F} on V are *equivalent*. That is, there are constants $m, M > 0$ such that

$$m\tilde{F}(v) \leq F(v) \leq M\tilde{F}(v), \quad v \in V.$$

The next theorem shows that the unit ball $B = \{v \in V : F(v) \leq 1\}$ is convex. It also shows that if F is symmetric, then F is a norm in the usual sense.

Proposition 1.4 (Triangle inequality). [She01b] For $v, w \in V$, we have

$$F(v + w) \leq F(v) + F(w)$$

with equality if and only if $w = \lambda v$ for some $\lambda \geq 0$.

Proposition 1.5 (Cauchy-Schwarz inequality). [She01b] For $v, y \in V$, $y \neq 0$, we have

$$g_y(y, v) \leq F(y)F(v),$$

with equality if and only if $v = \lambda y$ for some $\lambda \geq 0$.

The proofs of the above two propositions are somewhat technical (see e.g. [She01b]) and are therefore omitted.

Proposition 1.6. [She01b] Suppose $v, y \in V \setminus \{0\}$, and

$$g_v(v, w) = g_y(y, w)$$

for all $w \in V$. Then $v = y$.

Proof. Setting $w = v$ and $w = y$ yields

$$\begin{aligned} F^2(v) &= g_y(y, v) \leq F(v)F(y), \\ F^2(y) &= g_v(v, y) \leq F(v)F(y). \end{aligned}$$

Thus $F(y) = F(v)$, so

$$g_v(v, y) = F(v)F(y),$$

and by the Cauchy-Schwarz inequality, $v = y$. □

1.2 Legendre transformation

Definition 1.7 (Dual Minkowski norm). The *dual Minkowski norm* is the function $F^*: V^* \rightarrow \mathbb{R}$ is defined as

$$F^*(\xi) = \max\{\xi(y) : y \in V, F(y) = 1\}, \quad \xi \in V^*.$$

As $\{y \in V : F(y) = 1\}$ is compact, the dual Minkowski norm is well defined and finite. In what follows, we prove that a dual Minkowski norm is a Minkowski norm on V^* . For this purpose, we introduce the Legendre transformation.

Definition 1.8 (Legendre transformation). The *Legendre transformation* $\ell: V \rightarrow V^*$ is defined as $\ell(y) = g_y(y, \cdot)$ for $y \in V \setminus \{0\}$, and $\ell(0) = 0$.

The first part of the next proposition gives an algebraic relation between F, F^* and ℓ . The second part is essentially a variant of Riesz' theorem.

Proposition 1.9.

1. $F = F^* \circ \ell$.
2. The Legendre transformation is a bijection.

Proof. Property 1 is clear for $y = 0$, so suppose $y \neq 0$. Then

$$F(y) = \frac{g_y(y, y)}{F(y)} = \ell_y \left(\frac{y}{F(y)} \right) \leq F^* \circ \ell(y),$$

and by the Cauchy-Schwarz inequality we have

$$F^* \circ \ell(y) = \sup_{v \neq 0} \ell_y \left(\frac{v}{F(v)} \right) = \sup_{v \neq 0} \frac{g_y(y, v)}{F(v)} \leq F(y),$$

so property 1 holds. For property 2, let us first note that $\ell(y) = 0$ if and only if $y = 0$. It therefore suffices to show that $\ell: V \setminus \{0\} \rightarrow V^* \setminus \{0\}$ is a bijection. Proposition 1.6 implies injectivity. To prove surjectivity, suppose $\xi \in V^* \setminus \{0\}$. Let $\lambda = F^*(\xi)$, and let $y \in V$ be such that $F(y) = 1$ and $\xi(y) = \lambda$. Now $\xi(w) = 0$, if

$$w \in W_y = \{w \in V : g_y(y, w) = 0\}.$$

Indeed, if γ is the smooth curve $\gamma: (-\varepsilon, \varepsilon) \rightarrow F^{-1}(1)$,

$$\gamma(t) = \frac{y + tw}{F(y + tw)}, \quad t \in (-\varepsilon, \varepsilon),$$

then as y is a stationary point of $v \mapsto \xi(v)$, we have

$$0 = \left. \frac{d}{dt} \xi(\gamma(t)) \right|_{t=0} = \xi \left(\frac{w}{F(y)} - \frac{y}{F^2(y)} \frac{\partial F}{\partial y^i}(y) w^i \right),$$

and as $g_y(y, w) = 0$, the second term vanishes and $\xi(w) = 0$. For any $v \in V$ we have decomposition

$$v = w + g_y(y, v)y, \quad w = v - g_y(y, v)y \in W_y.$$

This decomposition and $\xi(w) = 0$ for $w \in W_y$ implies that $\xi = \ell(\lambda y)$. \square

Next we introduce some more notation. Let g^{ij} be the ij :th entry of the inverse matrix of (g_{ij}) , let $\{\theta^i\}$ be the dual basis to $\{e_i\}$, and let $\ell_i(y)$ be the i :th component of $\ell(y)$,

$$\ell_i(y) = \ell(y)(e_i) = \frac{1}{2} \frac{\partial F^2}{\partial y^i}(y).$$

Proposition 1.10.

1. The dual Minkowski norm is a Minkowski norm on V^* .
2. Let

$$g^{*ij}(\xi) = \frac{1}{2} \frac{\partial^2 F^{*2}}{\partial \xi_i \partial \xi_j}(\xi), \quad \xi \in V^* \setminus \{0\}. \quad (3)$$

Then

$$\ell(y) = \ell_j(y)\theta^j = g_{ij}(y)y^i\theta^j, \quad y \in V \setminus \{0\}, \quad (4)$$

$$\ell^{-1}(\xi) = g^{*ij}(\xi)\xi_i e_j, \quad \xi \in V^* \setminus \{0\}, \quad (5)$$

$$g^{ij}(y) = g^{*ij} \circ \ell(y), \quad y \in V \setminus \{0\}. \quad (6)$$

Proof. Let us first show that F^* is smooth on $V^* \setminus \{0\}$. In view of Proposition 1.9.1, it suffices to prove that ℓ is a diffeomorphism $\ell: V \setminus \{0\} \rightarrow V^* \setminus \{0\}$. By equation (4) (which is trivial), it follows that ℓ is smooth, and that the Jacobian of ℓ is $(D\ell)_{ij} = g_{ij}$. Hence, by the inverse function theorem, the inverse of ℓ is smooth. It is evident that F^* is 1-homogeneous, so it remains to check the positive definite condition on F^* . Differentiating $\frac{1}{2}F^2 = \frac{1}{2}F^{*2} \circ \ell$ with respect to y^i and y^j yields for $y \in V \setminus \{0\}$,

$$\frac{1}{2} \frac{\partial F^2}{\partial y^i}(y) = \frac{1}{2} \frac{\partial F^{*2}}{\partial \xi_k} \circ \ell(y) g_{ki}(y), \quad (7)$$

$$g_{ij}(y) = (g^{*kl} \circ \ell)(y) g_{ki}(y) g_{lj}(y) + \frac{1}{2} \frac{\partial F^{*2}}{\partial \xi_k} \circ \ell(y) \frac{\partial g_{ki}}{\partial y^j}(y). \quad (8)$$

Equation (7) implies that $\ell_i(y) = (g^{*kj} \circ \ell)(y) \ell_j(y) g_{ki}(y)$, so

$$y^j = g^{*jk} \circ \ell(y) \ell_k(y).$$

As g_{ij} is 0-homogeneous, we have

$$\frac{1}{2} \frac{\partial F^{*2}}{\partial \xi_k} \circ \ell(y) \frac{\partial g_{ki}}{\partial y^j}(y) = (g^{*km} \circ \ell)(y) \ell_m(y) \frac{\partial g_{ki}}{\partial y^j}(y) = y^k \frac{\partial g_{ij}}{\partial y^k}(y) = 0,$$

so the second term in equation (8) vanishes, and equation (6) follows. Let us recall that a matrix is positive definite if and only if all eigenvalues are positive, and eigenvalues are transformed as $\mu \mapsto 1/\mu$ under matrix inversion. Therefore equation (6) implies that g^{*ij} is positive definite, and F^* is a Minkowski norm. Equation (5) follows since the mapping ℓ^{-1} defined by this equation satisfies $\ell^{-1} \circ \ell = \text{id}_V$, and $\ell \circ \ell^{-1} = \text{id}_{V^*}$. \square

2 Finsler geometry

By an n -dimensional manifold M we mean a topological Hausdorff space with countable base that is locally homeomorphic to \mathbb{R}^n . In addition we assume that all transition functions are C^∞ -smooth. That is, we only consider C^∞ -smooth manifolds. The space of differential p -forms on M is denoted by $\Omega^p M$, and the tangent space of M is denoted by TM . By $\mathfrak{X}(M)$ we denote the set of vector fields on M . When we consider an object at some point $x \in M$, we use x as a sub-index on the object. For example, $\Omega_x^1 M$ is the set of 1-forms originating from x . If f is a diffeomorphism, then by Df we mean the tangent map and by f^* the pullback of f .

Suppose (x^i) are local coordinates around $x \in M$. Then we denote by $\frac{\partial}{\partial x^i}|_x$ the standard basis vectors for $T_x M$, and by $dx^i|_x$ the standard basis vectors for $T_x^* M$. When the base point x is clear from context, we simply write $\frac{\partial}{\partial x^i}$ and dx^i .

Definition 2.1 (Finsler manifold). A *Finsler manifold* is a manifold M and a function $F: TM \rightarrow [0, \infty)$ (called a *Finsler norm*) such that

1. F is smooth on $TM \setminus \{0\}$,
2. $F|_{T_x M}: T_x M \rightarrow [0, \infty)$ is a Minkowski norm for all $x \in M$.

Here $TM \setminus \{0\}$ is the *slashed tangent bundle*, that is,

$$TM \setminus \{0\} = \bigcup \{T_x M \setminus \{0\} : x \in M\}.$$

Example 2.2. Let (M, g) be a Riemannian manifold. Then

$$F(x, y) = \sqrt{g_x(y, y)}$$

is a Finsler norm on M .

In addition to Finsler norms, we will also study *co-Finsler norms*. These form a special class of Hamiltonian functions.

Definition 2.3 (co-Finsler norm). A *co-Finsler norm* on a manifold M is a function $H: T^*M \rightarrow [0, \infty)$ such that

1. H is smooth on $T^*M \setminus \{0\}$,
2. $H|_{T_x^* M}: T_x^* M \rightarrow [0, \infty)$ is a Minkowski norm for all $x \in M$.

2.1 The global Legendre transforms

Next we generalize the pointwise Legendre transformations to a global transformation between TM and T^*M . As a result we prove that Finsler and co-Finsler norms are in one-to-one correspondence.

The Legendre transform $T^*M \rightarrow TM$

Suppose H is a co-Finsler norm on a manifold M . Then for each $x \in M$ we have the pointwise Legendre transformation

$$\ell_x: T_x^*M \rightarrow T_x^{**}M$$

induced by the Minkowski norm $H|_{T_x^*M}$, and the canonical linear isomorphism

$$\iota: T_xM \rightarrow T_x^{**}M.$$

Then we define the *global Legendre transformation* as

$$\begin{aligned} \mathcal{L}: T^*M &\rightarrow TM, \\ \xi &\mapsto \iota^{-1} \circ \ell_{\pi(\xi)}(\xi), \end{aligned}$$

where $\pi: T^*M \rightarrow M$ is the canonical projection. It is clear that \mathcal{L} is well defined. In local coordinates, let

$$h^{ij}(\xi) = \frac{1}{2} \frac{\partial^2 H^2}{\partial \xi_i \partial \xi_j}(\xi), \quad \xi \in T^*M \setminus \{0\}. \quad (9)$$

Proposition 2.4. *Suppose \mathcal{L} is the Legendre transformation induced by a co-Finsler norm H .*

1. \mathcal{L} is a bijection $T^*M \rightarrow TM$ and a diffeomorphism $T^*M \setminus \{0\} \rightarrow TM \setminus \{0\}$.
2. $F = H \circ \mathcal{L}^{-1}$ is a Finsler norm on M .
3. If g_{ij} is as in equation (1), and h_{ij} is the inverse of h^{ij} , then

$$\mathcal{L}(\xi) = h^{ij}(\xi) \xi_i \frac{\partial}{\partial x^j}, \quad \xi \in T^*M \setminus \{0\}, \quad (10)$$

$$\mathcal{L}^{-1}(y) = g_{ij}(y) y^i dx^j, \quad y \in TM \setminus \{0\}, \quad (11)$$

$$g_{ij}(y) = h_{ij} \circ \mathcal{L}^{-1}(y), \quad y \in TM \setminus \{0\}. \quad (12)$$

Proof. Let us first prove equation (10) in part 3. For a fixed $x \in M$, let $\{e_i\}$ be the usual basis $\frac{\partial}{\partial x^i}$ induced by some local coordinates, and let $\{\theta^i\}$, $\{\Delta_i\}$ be dual bases for T_x^*M , $T_x^{**}M$, respectively. That is, $\{\theta^i\}$, $\{\Delta_i\}$ are defined by conditions $\theta^i(e_j) = \delta_j^i$ and $\Delta_i(\theta^j) = \delta_i^j$, whence $\iota(e_i) = \Delta_i$, $\iota^{-1}(\Delta_i) = e_i$, and $\{\theta^i\} = \{dx^i\}$. By equation (4),

$$\begin{aligned} \mathcal{L}(\xi) &= \iota^{-1}(h^{ij}(\xi) \xi_i \Delta_j) \\ &= h^{ij}(\xi) \xi_i \frac{\partial}{\partial x^j}, \end{aligned}$$

and equation (10) follows. For equation (11), let us first notice that if w_i are coordinates for T_x^*M , then

$$g_{ij}(y) = \frac{1}{2} \frac{\partial^2 H^2 \circ \ell_x^{-1}}{\partial w^i \partial w^j}(\iota(y)),$$

so by equation (5),

$$\begin{aligned} \mathcal{L}^{-1}(y) &= \ell_x^{-1} \circ \iota(y) \\ &= \frac{1}{2} \frac{\partial^2 H^2 \circ \ell_x^{-1}}{\partial w^i \partial w^j}(\iota(y)) (\iota \circ y)^i \theta^j \\ &= g_{ij}(y) y^i dx^j, \end{aligned}$$

and equation (11) follows. Equation (12) follows using equations (6) and (13);

$$\begin{aligned} h_{ij}(\xi) &= \frac{1}{2} \frac{\partial^2 H^2 \circ \ell_x^{-1}}{\partial w^i \partial w^j} \circ \ell_x(\xi) \\ &= g_{ij} \circ \mathcal{L}(\xi). \end{aligned}$$

In part 1, it is clear that \mathcal{L} is a bijection. Equation (10) shows that \mathcal{L} is smooth on $T^*M \setminus \{0\}$, and since the Jacobian of \mathcal{L} is of the form

$$D\mathcal{L} = \begin{pmatrix} I & 0 \\ * & h^{ij} \end{pmatrix},$$

part 1 follows by the inverse function theorem. For property 2, let us first show that F is 1-homogeneous. Suppose $y \in TM$. Then $y = \mathcal{L}(\xi)$ for some $\xi \in T^*M$, and as \mathcal{L} is 1-homogeneous we have

$$\mathcal{L}^{-1}(\lambda y) = \mathcal{L}^{-1}(\mathcal{L}(\lambda \xi)) = \lambda \xi = \lambda \mathcal{L}^{-1}(y), \quad \lambda > 0.$$

Since h^{ij} is positive definite, h_{ij} is positive definite, and g_{ij} is positive definite by equation (12). \square

The Legendre transform $TM \rightarrow T^*M$

Suppose F is a Finsler norm on a manifold M . For each $x \in M$, we can then introduce a pointwise Legendre transformation

$$\ell_x: T_x M \rightarrow T_x^* M$$

induced by the Minkowski norm $F|_{T_x M}$. Then we define the *global Legendre transformation* as

$$\begin{aligned} \mathcal{L}: TM &\rightarrow T^*M, \\ y &\mapsto \ell_{\pi(y)}(y), \end{aligned}$$

where $\pi: TM \rightarrow M$ is the canonical projection.

Proposition 2.5. *Suppose \mathcal{L} is the Legendre transformation induced by a Finsler norm F .*

1. \mathcal{L} is a bijection $TM \rightarrow T^*M$ and a diffeomorphism $TM \setminus \{0\} \rightarrow T^*M \setminus \{0\}$.
2. $H = F \circ \mathcal{L}^{-1}$ is a co-Finsler norm.
3. If g_{ij} be as in equation (1), h^{ij} be as in equation (9), and h_{ij} be the inverse of h^{ij} , then

$$\mathcal{L}(y) = g_{ij}(y)y^i dx^j, \quad y \in TM \setminus \{0\}, \quad (13)$$

$$\mathcal{L}^{-1}(\xi) = h^{ij}(\xi)\xi_i \frac{\partial}{\partial x^j}, \quad \xi \in T^*M \setminus \{0\}, \quad (14)$$

$$h^{ij}(\xi) = g^{ij} \circ \mathcal{L}^{-1}(\xi), \quad \xi \in T^*M \setminus \{0\}. \quad (15)$$

Proof. The proof is completely analogous to the proof of Proposition 2.4, but much simpler since there is no ι mapping. \square

Example 2.6 (Musical isomorphisms). Suppose (M, g) is a Riemannian manifold. Then $F(y) = \sqrt{g(y, y)}$ makes M into a Finsler manifold. The induced Legendre transformation acts on vectors and co-vectors as follows:

$$\begin{aligned} \mathcal{L}(y) &= g_{ij}(x)y^i dx^j, \quad y \in T_x M, \\ \mathcal{L}^{-1}(\xi) &= g^{ij}(x)\xi_i \frac{\partial}{\partial x^j}, \quad y \in T_x M. \end{aligned}$$

Here we use standard notation: $g_{ij}(x) = g(\frac{\partial}{\partial x^i}|_x, \frac{\partial}{\partial x^j}|_x)$, and $g^{ij}(x)$ is the inverse of (g_{ij}) . From the above formulas, we see that in this special case, the Legendre transformation reduces to the *musical isomorphisms* in Riemannian geometry; $\mathcal{L}(y) = y^\flat$, and $\mathcal{L}^{-1}(\xi) = \xi^\sharp$.

The next two results show that the Legendre transformations are in some sense well behaved.

Proposition 2.7. *Suppose \mathcal{L}_H is the Legendre transformation induced by a co-Finsler norm H , and \mathcal{L}_F is the Legendre transformation induced by the Finsler norm $F = H \circ \mathcal{L}_H^{-1}$. Then*

$$\mathcal{L}_F = \mathcal{L}_H^{-1}. \quad (16)$$

Similarly, if \mathcal{L}_F is the Legendre transformation induced by a Finsler norm F , and \mathcal{L}_H is the Legendre transformation induced by the co-Finsler norm $H = F \circ \mathcal{L}_F^{-1}$, then equation (16) also holds.

Proof. Both claims follow using equations (11) and (13). \square

Corollary 2.8. *On a fixed manifold, Finsler and co-Finsler norms are in one-to-one correspondence via the two Legendre transformations.*

Proof. Let T be mapping $F \mapsto F \circ \mathcal{L}_F^{-1}$ that maps a Finsler norm F to a co-Finsler norm, and let S be mapping $H \mapsto H \circ \mathcal{L}_H^{-1}$ that maps a co-Finsler norm H to a Finsler norm. If H is a co-Finsler norm, then

$$T \circ S(H) = T(F) = F \circ \mathcal{L}_F^{-1} = H \circ \mathcal{L}_H^{-1} \circ \mathcal{L}_F^{-1} = H$$

where $F = H \circ \mathcal{L}_H^{-1}$, and similarly, $S \circ T = \text{id}$. □

3 Geodesics

Suppose M is a manifold. Then a *curve* is a smooth mapping $c: (a, b) \rightarrow M$ such that $(Dc)_t \neq 0$ for all t . Such a curve has a *canonical lift* $\hat{c}: (a, b) \rightarrow TM \setminus \{0\}$ defined as $\hat{c}(t) = (Dc)(t)$, where Dc is the tangent of c . If, furthermore, M is a Finsler manifold with Finsler norm F , we define the *length* of c as

$$L(c) = \int_a^b F \circ \hat{c}(t) dt,$$

and the *energy* as

$$E(c) = \frac{1}{2} \int_a^b F^2 \circ \hat{c}(t) dt.$$

A curve c that satisfies $F \circ \hat{c} = 1$ is called *path-length parameterized*. The next proposition shows that every curve can be path-length parametrized, and the length of an oriented curve does not depend on its parametrization. The latter claim need not be true for the energy.

Proposition 3.1. *Suppose c is a curve on a Finsler manifold (M, F) .*

1. *If $\alpha: (a', b') \rightarrow (a, b)$ is a diffeomorphism with $\alpha' > 0$, then $\widehat{c \circ \alpha} = \alpha' \hat{c} \circ \alpha$, and $L(c \circ \alpha) = L(c)$.*
2. *There is a diffeomorphism $\alpha: (0, L(c)) \rightarrow (a, b)$ such that*

$$F \circ \widehat{c \circ \alpha} = 1. \tag{17}$$

Proof. The first claim follows since F is 1-homogeneous. For the second claim, let us define $\beta: (a, b) \rightarrow (0, L(c))$ by

$$\beta(s) = \int_a^s F \circ \hat{c}(t) dt.$$

Then $\beta'(s) = F \circ \hat{c}(s) > 0$, so by the inverse function theorem, β is smooth and invertible with smooth inverse. The sought diffeomorphism is $\alpha = \beta^{-1}$;

$$\begin{aligned} F \circ \widehat{c \circ \alpha} &= F((\beta^{-1})' \hat{c} \circ \alpha) \\ &= \frac{1}{\beta' \circ \beta^{-1}} F \circ \hat{c} \circ \alpha \\ &= 1. \end{aligned}$$

□

Definition 3.2 (Variation). Suppose $c: (a, b) \rightarrow M$ is a curve. Then a *variation* of c is a continuous mapping $H: [a, b] \times (-\varepsilon, \varepsilon) \rightarrow M$ for some $\varepsilon > 0$ such that

1. H is smooth on $(-\varepsilon, \varepsilon) \times (a, b)$,

and with notation $c_s(\cdot) = H(\cdot, s)$,

2. $c_0(t) = c(t)$, for all $t \in [a, b]$,
3. $c_s(a), c_s(b) \in M$ are constants not depending on $s \in (-\varepsilon, \varepsilon)$.

Definition 3.3 (Geodesic). A curve c in a Finsler manifold is a *geodesic* if L is stationary at c , that is, for any variation (c_s) of c ,

$$\left. \frac{d}{ds} L(c_s) \right|_{s=0} = 0.$$

Our next aim is to prove Proposition 3.6 which gives a local condition for a curve to be a geodesic. To do this, we need to operate with vectors on TM , that is, with elements in $T(TM)$. Let us therefore start by deriving their transformation properties. First, if (x^i) and $(\tilde{x}^i) = \tilde{x}^i(x)$ are local coordinates around some $x \in M$, then

$$\left. \frac{\partial}{\partial x^i} \right|_x = \left. \frac{\partial \tilde{x}^j}{\partial x^i} \frac{\partial}{\partial \tilde{x}^j} \right|_x. \quad (18)$$

Here $\frac{\partial \tilde{x}^j}{\partial x^i}$ is the Jacobian of the mapping taking (x^i) -coordinates into (\tilde{x}^i) -coordinates evaluated at the local x^i -coordinates for x .

Next, suppose $(x^i, y^i), (\tilde{x}^i, \tilde{y}^i)$ are standard local coordinates around $y \in T_x M$. That is, $\tilde{x}^i = \tilde{x}^i(x), \tilde{y}^i = \tilde{y}^i(x, y)$, and y^i are coordinates in the $\frac{\partial}{\partial x^i}$ basis. It follows that vectors

$$\left. \frac{\partial}{\partial x^i} \right|_y, \quad \left. \frac{\partial}{\partial y^i} \right|_y, \quad \left. \frac{\partial}{\partial \tilde{x}^i} \right|_y, \quad \left. \frac{\partial}{\partial \tilde{y}^i} \right|_y \in T(TM \setminus \{0\})$$

satisfy transformation rules

$$\left. \frac{\partial}{\partial x^i} \right|_y = \left. \frac{\partial \tilde{x}^r}{\partial x^i} \frac{\partial}{\partial \tilde{x}^r} \right|_y + \frac{\partial^2 \tilde{x}^r}{\partial x^i \partial x^s} y^s \left. \frac{\partial}{\partial \tilde{y}^r} \right|_y, \quad (19)$$

$$\left. \frac{\partial}{\partial y^i} \right|_y = \left. \frac{\partial \tilde{x}^r}{\partial x^i} \frac{\partial}{\partial \tilde{y}^r} \right|_y. \quad (20)$$

In fact, equation (18) implies that $\tilde{y}^i = \frac{\partial \tilde{x}^i}{\partial x^r} y^r$, so

$$\left. \frac{\partial}{\partial x^i} \right|_y = \left. \frac{\partial \tilde{x}^r}{\partial x^i} \frac{\partial}{\partial \tilde{x}^r} \right|_y + \frac{\partial \tilde{y}^r}{\partial x^i} \left. \frac{\partial}{\partial \tilde{y}^r} \right|_y,$$

and equation (19) follows. The proof of equation (20) is similar.

Lemma 3.4 (Euler equations). Suppose $f: TM \setminus \{0\} \rightarrow \mathbb{R}$ is a smooth function. Then a smooth curve $c: (a, b) \rightarrow M$ is stationary for $c \mapsto \int_a^b f \circ \hat{c}(t) dt$ if and only if for each t there are local coordinates around $\hat{c}(t)$ such that

$$\frac{\partial f}{\partial x^i} \circ \hat{c} - \frac{d}{dt} \left(\frac{\partial f}{\partial y^i} \circ \hat{c} \right) = 0. \quad (21)$$

Moreover, condition (21) does not depend on local coordinates.

Proof. The last claim follows from equations (19) and (20). Before the proof, let us begin with an observation. Suppose c is a curve, and $a = t_1 < \dots < t_N = b$ is a partition of the domain of c such that each (t_i, t_{i+1}) is mapped into one coordinate chart. Furthermore, suppose $H(t, s) = c_s(t)$ is a variation of c and by restricting the value of s , we can assume that each partition (t_i, t_{i+1}) is mapped into one coordinate chart by H . If K is the mapping $c \mapsto \int_a^b f \circ \hat{c}(t) dt$, then

$$\begin{aligned} & \left. \frac{d}{ds} K(c_s) \right|_{s=0} \\ &= \sum_{k=1}^{N-1} \int_{t_k}^{t_{k+1}} \left[\frac{\partial f}{\partial x^i} \circ \hat{c}(t) \frac{\partial H^i}{\partial s}(t, 0) + \frac{\partial f}{\partial y^i} \circ \hat{c}(t) \frac{\partial^2 H^i}{\partial t \partial s}(t, 0) \right] dt \\ &= \sum_{k=1}^{N-1} \int_{t_k}^{t_{k+1}} \left[\frac{\partial f}{\partial x^i} \circ \hat{c}(t) - \frac{d}{dt} \left(\frac{\partial f}{\partial y^i} \circ \hat{c}(t) \right) \right] \frac{\partial H^i}{\partial s}(t, 0) dt. \end{aligned}$$

For the actual proof, suppose that $c: (a, b) \rightarrow M$ is a stationary curve. Then restrictions of c to subsets of (a, b) are also stationary, so we can assume that c is contained in one coordinate chart, and the claim follows from the above calculation. On the other hand, if condition (21) holds, then c is stationary since equation (21) is independent of local coordinates. \square

One can prove that a stationary curve is smooth if it is piecewise smooth [She01b]. Intuitively, this is easy to understand; if a geodesic has a kink, it can be shortened by smoothing.

Definition 3.5 (Geodesic coefficients). In a Finsler manifold, the *geodesic coefficients* are locally defined functions

$$G^i(y) = \frac{1}{4} g^{ik}(y) \left(2 \frac{\partial g_{jk}}{\partial x^l} - \frac{\partial g_{jl}}{\partial x^k} \right) y^j y^l, \quad y \in TM \setminus \{0\}. \quad (22)$$

Proposition 3.6 (Geodesic equation). A curve $c: I \rightarrow M$ is stationary for E if and only if for each $t \in I$ there are local coordinates such that

$$\frac{d^2 c^i}{dt^2} + 2G^i \circ \hat{c} = 0.$$

Proof. This follows by Lemma 3.4, relations $F^2(y) = g_{ij}(y) y^i y^j$, $\frac{\partial F^2}{\partial y^i}(y) = 2g_{ij} y^j$, and Euler's theorem. \square

Definition 3.7 (Geodesic spray). Geodesic spray $\mathbb{G} \in \mathfrak{X}(TM \setminus \{0\})$ on a Finsler manifold is locally defined as

$$\mathbb{G}|_y = y^i \frac{\partial}{\partial x^i} \Big|_y - 2G^i(y) \frac{\partial}{\partial y^i} \Big|_y. \quad (23)$$

In Proposition 7.14 we prove that \mathbb{G} is well defined, that is, \mathbb{G} does not depend on local coordinates. Without any circular argument, let us assume this to be known. (Alternatively, one can prove this by a very long calculation, but there is no need to do that here.) It follows that G^i satisfy the transformation rule

$$\tilde{G}^r = \frac{\partial \tilde{x}^r}{\partial x^i} G^i - \frac{1}{2} \frac{\partial^2 \tilde{x}^r}{\partial x^i \partial x^s} y^i y^s. \quad (24)$$

The next proposition is a coordinate independent restatement of Proposition 3.6.

Proposition 3.8. *Suppose π is the canonical projection $\pi: TM \rightarrow M$. If c is an integral curve of \mathbb{G} , then $\pi \circ c$ is a stationary curve of E , and $c = \widehat{\pi \circ c}$. Conversely, if b is a stationary curve for E , then \hat{b} is an integral curve of \mathbb{G} .*

It turns out that stationary curves of E and L almost coincide. The first half of this equivalence is contained in the proposition below. After we introduce some tools from symplectic geometry we also prove the converse (Proposition 7.16); every stationary curve of E is a geodesic. In view of this equivalence, it will be convenient to consider only stationary points of E . Traditionally this is done for two reasons. First, it gives slightly simpler formulas. For example, compare derivatives of $F = \sqrt{g_{ij}(x)y^i y^j}$ and $F^2 = g_{ij}(x)y^i y^j$, and second, stationary curves of E naturally generalize also to the case when F is non-degenerate (which is not relevant here).

Proposition 3.9. *If c is a geodesic, and α is a diffeomorphism such that $c \circ \alpha$ is parameterized with respect to pathlength, then $c \circ \alpha$ is a stationary point of E .*

Proof. Using Lemma 3.4 and the 1-homogeneity of F , it follows that $c \circ \alpha$ is a stationary curve for L . By writing derivatives as $\frac{\partial F}{\partial x^i} = \frac{1}{2F} \frac{\partial F^2}{\partial x^i}$ and using Lemma 3.4 again the result follows. \square

4 Horizontal and vertical decompositions

In many respects, Finsler geometry is analogous to Riemann geometry. However, a typical difference is that in Finsler geometry objects exist on TM whereas in Riemann geometry they exist on M . For example, in Finsler geometry, curvature is a tensor on $TM \setminus \{0\}$, whereas in Riemannian geometry, it is a tensor on M . For this reason we need to study vectors and co-vectors on TM , that is, elements in $T(TM \setminus \{0\})$ and $T^*(TM \setminus \{0\})$. Equations (19)-(20) already give the transformation rules for basis vectors in $T(TM \setminus \{0\})$. In this section we define the horizontal-vertical decomposition in $T(TM \setminus \{0\})$ and $T^*(TM \setminus \{0\})$. This decomposition will greatly simplify calculations in local coordinates. It will also give a certain structure compatible with the Finsler metric. For example, the tangent of a geodesic will be a horizontal vector. Also, the derivative of F will be a vertical co-vector. Some immediate applications of the horizontal-vertical decomposition are given in Section 4.1.

In order to introduce the horizontal-vertical decomposition, one needs a non-linear connection, that is, one needs some structure on $TM \setminus \{0\}$.

Definition 4.1 (Non-linear connection). A *non-linear connection* on a manifold M is a collection of locally defined 1-homogeneous functions N_j^i on $TM \setminus \{0\}$ satisfying transformation rules

$$\frac{\partial \tilde{x}^j}{\partial x^i} \tilde{N}_j^h = \frac{\partial \tilde{x}^h}{\partial x^j} N_i^j - \frac{\partial^2 \tilde{x}^h}{\partial x^i \partial x^j} y^j.$$

Let G^i be the coefficients for the geodesic spray, and let

$$N_j^i = \frac{\partial G^i}{\partial y^j}. \quad (25)$$

Then N_j^i are 1-homogeneous, and by differentiating equation (24) we see that N_j^i are coefficients for a non-linear connection. It is the only non-linear connection we shall use in this work. However, let us emphasize that one can study non-linear connections also without Finsler geometry. Concepts such as covariant derivative, geodesics, and curvature can all be defined from only a non-linear connection [MA94].

Decomposition of $T(TM \setminus \{0\})$

Equation (19) shows that the vector subspace $\text{span}\{\frac{\partial}{\partial x^i}|_y : i = 1, \dots, n\}$ depends on local coordinates. Therefore one can not talk about “ $\frac{\partial}{\partial x^i}$ ”-directions in $T(TM \setminus \{0\})$. However, when M is equipped with a non-linear connection N_j^i , let

$$\frac{\delta}{\delta x^i}|_y = \frac{\partial}{\partial x^i}|_y - N_i^k(y) \frac{\partial}{\partial y^k}|_y \in T(TM \setminus \{0\}),$$

whence

$$\frac{\delta}{\delta x^i} \Big|_y = \frac{\partial \tilde{x}^r}{\partial x^i} \frac{\delta}{\delta \tilde{x}^r} \Big|_y.$$

Thus, the $2n$ -dimensional vector space $T_y(TM \setminus \{0\})$ has two n -dimensional subspaces,

$$\mathcal{V}_y TM = \text{span} \left\{ \frac{\partial}{\partial y^i} \Big|_y \right\}, \quad \mathcal{H}_y TM = \text{span} \left\{ \frac{\delta}{\delta x^i} \Big|_y \right\},$$

and these are independent of local coordinates. Let us also define

$$\mathcal{V}TM = \bigcup_{y \in TM \setminus \{0\}} \mathcal{V}_y TM, \quad \mathcal{H}TM = \bigcup_{y \in TM \setminus \{0\}} \mathcal{H}_y TM,$$

whence pointwise

$$T(TM \setminus \{0\}) = \mathcal{V}TM \oplus \mathcal{H}TM.$$

Vectors in $\mathcal{V}TM$ are called *vertical vectors*, and vectors in $\mathcal{H}TM$ are called *horizontal vectors*.

The next example shows that the tangent of a geodesics is always a horizontal vector. Thus, in some sense, horizontal vectors are more important than vertical vectors. This also motivates that name; one can move horizontally, but not vertically.

Example 4.2. The coefficients G^i for the geodesic spray are 2-homogeneous. Hence $2G^i = y^j \frac{\partial G^i}{\partial y^j} = y^j N_j^i$, so

$$\mathbb{G} = y^i \frac{\delta}{\delta x^i},$$

and $\mathbb{G}(y)$ is horizontal for all $y \in TM \setminus \{0\}$.

Decomposition of $T^*(TM \setminus \{0\})$

On TM , the 1-forms dx^i and dy^i satisfy

$$dx^i \Big|_y = \frac{\partial x^i}{\partial \tilde{x}^r} d\tilde{x}^r \Big|_y, \quad (26)$$

$$dy^i \Big|_y = \frac{\partial x^i}{\partial \tilde{x}^r} d\tilde{y}^r \Big|_y + \frac{\partial^2 x^i}{\partial \tilde{x}^r \partial \tilde{x}^s} \tilde{y}^r d\tilde{x}^s \Big|_y. \quad (27)$$

These transformation rules follow from transformation rules (19)-(20) and the following lemma:

Lemma 4.3. *Suppose $\{a_i\}, \{\tilde{a}_i\}$ are bases for a finite dimensional vector space V . Furthermore, suppose that $\{\alpha^i\}$, and $\{\tilde{\alpha}^i\}$ are corresponding dual bases. Say, α^i is defined by conditions: $\alpha^i: V \rightarrow \mathbb{R}$ is linear, and $\alpha^i(a_j) = \delta_j^i$. Then*

$$\tilde{\alpha}^j = \sum_m \tilde{\alpha}^j(a_m) \alpha^m.$$

Proof. If $\tilde{\alpha}^j = \sum_m \Lambda_m^j \alpha^m$, then $\tilde{\alpha}^j(a_m) = \Lambda_m^j$. □

Let

$$\delta y^i|_y = dy^i|_y + N_j^i(y) dx^j|_y,$$

whence

$$\delta y^i|_y = \frac{\partial x^i}{\partial \tilde{x}^r} \delta \tilde{y}^r|_y.$$

Thus the $2n$ -dimensional vector space $T_y^*(TM \setminus \{0\})$ has two n -dimensional subspaces,

$$\mathcal{V}_y^*TM = \text{span} \{ \delta y^i|_y \}, \quad \mathcal{H}_y^*TM = \text{span} \{ dx^i|_y \},$$

and these are independent of local coordinates. Then pointwise

$$T^*(TM \setminus \{0\}) = \mathcal{V}^*TM \oplus \mathcal{H}^*TM.$$

Co-vectors in \mathcal{V}^*TM are called *vertical covectors*, and co-vectors in \mathcal{H}^*TM are called *horizontal covectors*.

Proposition 4.4. *Suppose $\frac{\delta}{\delta x^i}$, $\frac{\partial}{\partial y^i}$, dx^i , and δy^i are defined via the non-linear connection (25). Then*

$$\begin{aligned} dx^i \left(\frac{\delta}{\delta x^j} \right) &= \delta_j^i, & dx^i \left(\frac{\partial}{\partial y^j} \right) &= 0, \\ \delta y^i \left(\frac{\delta}{\delta x^j} \right) &= 0, & \delta y^i \left(\frac{\partial}{\partial y^j} \right) &= \delta_j^i, \end{aligned} \quad (28)$$

$$\begin{aligned} \left[\frac{\delta}{\delta x^j}, \frac{\delta}{\delta x^k} \right] &= \left(\frac{\delta N_j^m}{\delta x^k} - \frac{\delta N_k^m}{\delta x^j} \right) \frac{\partial}{\partial y^m}, \\ \left[\frac{\delta}{\delta x^i}, \frac{\partial}{\partial y^j} \right] &= \left[\frac{\delta}{\delta x^j}, \frac{\partial}{\partial y^i} \right] = \frac{\partial N_j^k}{\partial y^i} \frac{\partial}{\partial y^k}, \\ \left[\frac{\partial}{\partial y^i}, \frac{\partial}{\partial y^j} \right] &= 0. \end{aligned} \quad (29)$$

Proof. The last three equations follow from the definition of the *Lie bracket*; if X, Y are vector fields, then $[X, Y]$ is the vector field such that $[X, Y](f) = X(Y(f)) - Y(X(f))$. The first equality in equation (29) follows since

$$\frac{\partial N_j^i}{\partial y^k} = \frac{\partial N_k^i}{\partial y^j}.$$

□

Proposition 4.5. *If $f: TM \setminus \{0\} \rightarrow \mathbb{R}$ is a smooth function, then*

$$df = \frac{\delta f}{\delta x^i} dx^i + \frac{\partial f}{\partial y^i} \delta y^i.$$

4.1 Applications

Suppose M is a manifold with a Finsler metric F . Then two immediate applications of the horizontal–vertical decomposition are the Sasaki metric and the almost complex structure for $T(TM \setminus \{0\})$.

Sasaki metric

Let

$$\hat{g} = g_{ij}(y)dx^i \otimes dx^j + g_{ij}(y)\delta y^i \otimes \delta y^j.$$

Then \hat{g} is a Riemannian metric on $TM \setminus \{0\}$ known as the *Sasaki metric*. The Legendre transformation induced by \hat{g} ,

$$b: T(TM \setminus \{0\}) \rightarrow T^*(TM \setminus \{0\})$$

is given by

$$b\left(\frac{\delta}{\delta x^i}\right) = g_{ik}dx^k, \quad b\left(\frac{\partial}{\partial y^i}\right) = g_{ik}\delta y^k.$$

Another Riemannian metrics on $TM \setminus \{0\}$ is the *Cheeger-Gromoll metric*. For both of these metrics, one can derive explicit expressions for the covariant derivative and curvature. For example, see [Kap01].

Almost complex structure

Suppose E is a even dimensional manifold, and $J: TE \rightarrow TE$ is a linear map in each tangent space. Then J is an *almost complex structure* if $J^2 = -\text{Id}$ [MS97].

Using the horizontal–vertical decomposition we can define an almost complex structure $J: T(TM \setminus \{0\}) \rightarrow T(TM \setminus \{0\})$ by setting

$$J\left(\frac{\delta}{\delta x^i}\right) = \frac{\partial}{\partial y^i}, \quad J\left(\frac{\partial}{\partial y^i}\right) = -\frac{\delta}{\delta x^i}. \quad (30)$$

Then $J^2 = -\text{Id}$, and J does not depend on the local coordinates appearing in the definition. The map J is *compatible* with the Sasaki metric. That is

$$\hat{g}(X, Y) = \hat{g}(JX, JY), \quad X, Y \in T(TM \setminus \{0\}).$$

The *Nijenhuis tensor* associated with an almost complex structure J is defined by

$$N(X, Y) = [JX, JY] - J[JX, Y] - J[X, JY] - [X, Y]$$

for vector fields X, Y .

Proposition 4.6. *Every Nijenhuis tensor N satisfies properties:*

1. N is bilinear over smooth functions.
2. N is anti-symmetric.
3. $N(X, JX) = 0$ for any vector field X .

Proof. If f, g are functions and X, Y are vector fields, then the Lie bracket satisfies

$$[fX, gY] = fX(g)Y - gY(f)X + fg[X, Y].$$

Using this identity, it follows that

$$N(fX, gY) = fgN(X, Y),$$

and the first property follows. The latter two properties are immediate. \square

Proposition 4.7. *The Nijenhuis tensor for the almost complex structure (30) is given by*

$$\begin{aligned} N\left(\frac{\delta}{\delta x^i}, \frac{\delta}{\delta x^j}\right) &= -\left[\frac{\delta}{\delta x^i}, \frac{\delta}{\delta x^j}\right], \\ N\left(\frac{\delta}{\delta x^i}, \frac{\partial}{\partial y^j}\right) &= J\left[\frac{\delta}{\delta x^i}, \frac{\delta}{\delta x^j}\right], \\ N\left(\frac{\partial}{\partial y^i}, \frac{\partial}{\partial y^j}\right) &= \left[\frac{\delta}{\delta x^i}, \frac{\delta}{\delta x^j}\right]. \end{aligned}$$

The Newlander-Nirenberg theorem states that an almost complex structure is *integrable* (see [MS97]) if and only if the Nijenhuis tensor vanishes identically. Thus, for the almost complex structure $J: T(TM \setminus \{0\}) \rightarrow T(TM \setminus \{0\})$, this is the case if $\left[\frac{\delta}{\delta x^i}, \frac{\delta}{\delta x^j}\right] = 0$ identically for all i, j . In Section 6 we will see that this is equivalent to the curvature being zero.

5 Finsler connections

5.1 Finsler connections

Definition 5.1 (Finsler connection). A *Finsler connection* is determined by a triple (N, F, C) where N is a non-linear connection on M and $F = (F_{jk}^i)$, $C = (C_{jk}^i)$ are collections of locally defined 0-homogeneous functions $F_{jk}^i, C_{jk}^i: TM \setminus \{0\} \rightarrow \mathbb{R}$ satisfying the transformation rules

$$\frac{\partial \tilde{x}^l}{\partial x^i} F_{jk}^i = \frac{\partial^2 \tilde{x}^l}{\partial x^j \partial x^k} + \frac{\partial \tilde{x}^r}{\partial x^j} \frac{\partial \tilde{x}^s}{\partial x^k} \tilde{F}_{rs}^l, \quad (31)$$

$$C_{jk}^i = \frac{\partial x^i}{\partial \tilde{x}^p} \frac{\partial \tilde{x}^q}{\partial x^j} \frac{\partial \tilde{x}^r}{\partial x^k} \tilde{C}_{qr}^p. \quad (32)$$

Suppose $\pi: TM \rightarrow M$ is the canonical projection. The *Finsler connection* (induced by (N, F, C)) is the mapping

$$\nabla: T_y(TM \setminus \{0\}) \times \mathfrak{X}(M) \rightarrow T_{\pi(y)}(M), \quad (Y, X) \mapsto \nabla_Y(X)$$

defined by the properties

1. ∇ is linear over \mathbb{R} in X and Y (but not necessarily in y),
2. If $f \in C^\infty(M)$ and $y \in T_x M \setminus \{0\}$, then in local coordinates

$$\begin{aligned} \nabla_{\frac{\delta}{\delta x^i}|_y} (f \frac{\partial}{\partial x^j} \Big|_x) &= df(\frac{\partial}{\partial x^i} \Big|_x) \frac{\partial}{\partial x^j} \Big|_x + f F_{ij}^m(y) \frac{\partial}{\partial x^m} \Big|_x, \\ \nabla_{\frac{\partial}{\partial y^i}|_y} (f \frac{\partial}{\partial x^j} \Big|_x) &= f C_{ij}^m(y) \frac{\partial}{\partial x^m} \Big|_x. \end{aligned}$$

From the transformation properties of F_{jk}^i and C_{jk}^i it follows that

$$\begin{aligned} \nabla_{\frac{\delta}{\delta x^i}}(X) &= \frac{\partial \tilde{x}^r}{\partial x^i} \nabla_{\frac{\delta}{\delta \tilde{x}^r}}(X), \\ \nabla_{\frac{\partial}{\partial y^i}}(X) &= \frac{\partial \tilde{x}^r}{\partial x^i} \nabla_{\frac{\partial}{\partial \tilde{y}^r}}(X), \end{aligned}$$

for all $X \in \mathfrak{X}(M)$, so ∇ does not depend on the local coordinates.

Below are four examples of Finsler connections [Ana96]. Of these, the Berwald connection depends only on a non-linear connection. All the other connections depend on the Finsler norm. Thus, a non-linear connection defines a non-linear covariant derivative and a linear Finsler connection.

Chern-Rund connection

Let (M, F) be a Finsler manifold, and let

$$\begin{aligned} \Gamma_{ijk} &= \frac{1}{2} \left(\frac{\delta g_{ik}}{\delta x^j} + \frac{\delta g_{ij}}{\delta x^k} - \frac{\delta g_{jk}}{\delta x^i} \right), \\ \Gamma_{jk}^i &= g^{ir} \Gamma_{rjk}, \end{aligned}$$

be locally defined functions. Then $(N_j^i, \Gamma_{jk}^i, 0)$ is the *Chern-Rund connection*.

That Γ_{jk}^i satisfies the appropriate transformation rule follows from

$$\Gamma_{ijk} = \frac{\partial \tilde{x}^p}{\partial x^i} \left(\frac{\partial^2 \tilde{x}^q}{\partial x^j \partial x^k} \tilde{g}_{pq} + \frac{\partial \tilde{x}^q}{\partial x^j} \frac{\partial \tilde{x}^r}{\partial x^k} \tilde{\Gamma}_{pqr} \right), \quad (33)$$

$$g^{ij} = \frac{\partial x^i}{\partial \tilde{x}^r} \frac{\partial x^j}{\partial \tilde{x}^s} \tilde{g}^{rs}. \quad (34)$$

The latter transformation rule follows from

$$g_{ij} = \frac{\partial \tilde{x}^r}{\partial x^i} \frac{\partial \tilde{x}^s}{\partial x^j} \tilde{g}_{rs}. \quad (35)$$

Berwald connection

Let $G_{jk}^i = \frac{\partial N_j^i}{\partial y^k}$, where N_j^i are given by equation 25. Then $(N_j^i, G_{jk}^i, 0)$ is the *Berwald connection*.

Hashiguchi connection

On a Finsler manifold the *Cartan tensor* C_{ijk} is defined as

$$C_{ijk} = \frac{1}{2} \frac{\partial g_{ij}}{\partial y^k} = \frac{1}{4} \frac{\partial^3 F^2}{\partial y^i \partial y^j \partial y^k},$$

$$C_{jk}^l = g^{li} C_{ijk}.$$

Coefficients C_{jk}^i satisfy equation (32), and the connection $(N_j^i, G_{jk}^i, C_{jk}^i)$ is the *Hashiguchi connection*.

Cartan connection

The *Cartan connection* is the Finsler connection $(N_j^i, \Gamma_{jk}^i, C_{jk}^i)$.

5.2 Covariant derivative

Definition 5.2 (Covariant derivative). Suppose M is a manifold with a non-linear connection N_j^i . Then the *covariant derivative* (induced by N_j^i) is a mapping

$$D: T_x M \setminus \{0\} \times \mathfrak{X}(M) \rightarrow T_x M \setminus \{0\}, \quad (y, X) \mapsto D_y(X)$$

determined by the following properties:

1. $D_y(X + Y) = D_y(X) + D_y(Y)$ for all $X, Y \in \mathfrak{X}(M)$ and $y \in TM \setminus \{0\}$,

2. $D_y(fX) = df(y)X + fD_y(X)$ for all $X \in \mathfrak{X}(M)$ and $f \in C^\infty(M)$,
3. in local coordinates, $D_y(\frac{\partial}{\partial x^i}|_x) = N_i^j(y)\frac{\partial}{\partial x^j}|_x$ for all $y \in T_xM \setminus \{0\}$.

Using the transformation rule for N_j^i , it follows that

$$D_y(\frac{\partial}{\partial x^i}|_x) = \frac{\partial \tilde{x}^j}{\partial x^i} D_y(\frac{\partial}{\partial \tilde{x}^j}) + d(\frac{\partial \tilde{x}^h}{\partial x^i})(y) \frac{\partial}{\partial \tilde{x}^h}|_x$$

and D_y is well defined. In general, $D_y(X)$ does not need to be linear in the lower argument. This is why N_j^i called a non-linear connection.

5.3 Some properties of basic Finsler quantities

Let $\mathcal{L}: T^*M \rightarrow TM$ be the Legendre transformation induced by a co-Finsler metric h . In local coordinates, let $\mathcal{L}(\xi) = \mathcal{L}^i(\xi)\frac{\partial}{\partial x^i}$ and $\mathcal{L}^{-1}(y) = \mathcal{L}_i^{-1}(y)dx^i$ for $\xi \in T^*M$ and $y \in TM$, whence

$$\begin{aligned} \mathcal{L}^i(\xi) &= h^{ij}(\xi)\xi_j, & \xi \in T^*M, \\ \mathcal{L}_i^{-1}(y) &= g_{ij}(y)y^j, & y \in TM. \end{aligned}$$

Properties of Γ

Let $C_{ijkl} = \frac{\partial C_{ijk}}{\partial y^l}$. Furthermore, let us define L_{ijk} as

$$L_{ijk} = \frac{\partial C_{ijk}}{\partial x^s} y^s - 2C_{ijk}sG^s - N_i^s C_{sjk} - N_j^s C_{sik} - N_k^s C_{sij}.$$

These are components determining the *Landsberg tensor* [She01b]. The functions L_{ijk} are symmetric in the indices i, j, k ; exchanging any two indices of i, j, k does not change L_{ijk} . Also, as $C_{ijk}y^k = 0$, and $C_{ijkl}y^l = -C_{ijk}$, it follows that

$$L_{ijk}y^i = L_{jik}y^j = L_{kji}y^k = 0. \quad (36)$$

Lemma 5.3 (Properties of Chern-Rund connection).

$$\Gamma_{ijk} = g_{im}G_{jk}^m - L_{ijk} \quad (37)$$

$$\Gamma_{ijk} = \Gamma_{ikj} \quad (38)$$

$$\Gamma_{jk}^i y^j = N_k^i \quad (39)$$

$$\Gamma_{jk}^i \mathcal{L}_i^{-1} = G_{jk}^i \mathcal{L}_i^{-1} = \Gamma_{ijk} y^i \quad (40)$$

Proof. Let first us prove equation (37). From the definition of Γ_{ijk} it follows that

$$\Gamma_{ijk} = \gamma_{ijk} - N_j^s C_{sik} - N_k^s C_{sij} + N_i^s C_{sjk}$$

where

$$\gamma_{ijk} = \frac{1}{2} \left(\frac{\partial g_{ik}}{\partial x^j} + \frac{\partial g_{ij}}{\partial x^k} - \frac{\partial g_{jk}}{\partial x^i} \right).$$

Differentiating the expression for $g_{is}G^s$ (see equation (22)) with respect to y^j and y^k and using the identity $\frac{\partial C_{ijk}}{\partial y^r} y^i = 0$ gives

$$g_{is}G_{jk}^s = \gamma_{ijk} + \frac{\partial C_{ijk}}{\partial x^s} y^s - 2C_{ijk}sG^s - 2N_j^s C_{sik} - 2N_k^s C_{sij},$$

and equation (37) follows. The other equations follow from equations (36) and (37). \square

Lemma 5.4 (Derivatives of g_{ij}, h^{ij}).

$$\frac{\partial \mathcal{L}_j^{-1}}{\partial x^k} = \frac{\partial g_{ij}}{\partial x^k} y^i = g_{js} N_k^s + \Gamma_{ijk} y^i \quad (41)$$

$$\frac{\partial \mathcal{L}^j}{\partial x^k} = \frac{\partial h^{ij}}{\partial x^k} \xi_i = \left(\frac{\partial g^{ij}}{\partial x^k} \mathcal{L}_i^{-1} \right) \circ \mathcal{L} = \left(-N_k^j - g^{js} \Gamma_{rsk} y^r \right) \circ \mathcal{L} \quad (42)$$

$$\frac{\partial h^2}{\partial x^k} = \frac{\partial h^{ij}}{\partial x^k} \xi_i \xi_j = \left(\frac{\partial g^{ij}}{\partial x^k} \mathcal{L}_i^{-1} \mathcal{L}_j^{-1} \right) \circ \mathcal{L} = \left(-2N_k^r \mathcal{L}_r^{-1} \right) \circ \mathcal{L} \quad (43)$$

Proof. Equation (41) follows from $\frac{\delta g_{ij}}{\delta x^k} = \Gamma_{ijk} + \Gamma_{jik}$ and equation (39). The second equality in equation (42) follows since $h^{ij} = g^{ij} \circ \mathcal{L}$, and

$$\begin{aligned} \frac{\partial g^{ij}}{\partial y^r} \mathcal{L}_j^{-1} &= \frac{\partial g^{ij}}{\partial y^r} g_{js} y^s \\ &= -g^{ij} \frac{\partial g_{js}}{\partial y^r} y^s \\ &= 0. \end{aligned}$$

The third equality in equation (42) follows by a similar calculation for $\frac{\partial g^{ij}}{\partial x^r} \mathcal{L}_j^{-1}$. Equality (43) follows from equations (42), (39), and (40). \square

6 Curvature

In Riemann geometry, the Riemann curvature tensor is a tensor on M . We next derive an analogous curvature tensor in a Finsler setting, which will be a tensor on $TM \setminus \{0\}$.

Let us first note that

$$\left[\frac{\delta}{\delta x^j}, \frac{\delta}{\delta x^k} \right] = - \left(\frac{\delta N_k^m}{\delta x^j} - \frac{\delta N_j^m}{\delta x^k} \right) \frac{\partial}{\partial y^m}.$$

where $[\cdot, \cdot]$ is the Lie bracket for vector fields. Let us define

$$R_{jk}^m = \frac{\delta N_k^m}{\delta x^j} - \frac{\delta N_j^m}{\delta x^k}.$$

Proposition 6.1 (Mo). *[She01a] $\mathcal{H}(M)$ is a submanifold near $y \in TM \setminus \{0\}$ if and only if all the R_{ij}^m -symbols vanish in a neighbourhood of y .*

Proof. This follows from a standard result about commuting vector fields. See for example [Con93], p. 110. \square

In addition to R_{ij}^m , let us furthermore define

$$R_{ijk}^m = \frac{\partial R_{jk}^m}{\partial y^i},$$

and the *curvature tensor* R , as

$$R = R_{ijk}^m dx^i \otimes dx^j \otimes dx^k \otimes \frac{\delta}{\delta x^m}.$$

To see that R is a tensor, let us first note that on TM , the 1-forms dx^i and dy^i satisfy

$$\begin{aligned} dx^i|_y &= \frac{\partial x^i}{\partial \tilde{x}^r} d\tilde{x}^r|_y, \\ dy^i|_y &= \frac{\partial x^i}{\partial \tilde{x}^r} d\tilde{y}^r|_y + \frac{\partial^2 x^i}{\partial \tilde{x}^r \partial \tilde{x}^s} \tilde{y}^r d\tilde{x}^s|_y. \end{aligned}$$

(Actually, similarly as on the tangent bundle, one can also define horizontal and vertical 1-forms on $TM \setminus \{0\}$, but we shall not need these. See for example [She01b, She01a].) Secondly, on overlapping coordinates,

$$\left[\frac{\delta}{\delta \tilde{x}^i}, \frac{\delta}{\delta \tilde{x}^j} \right] = \frac{\partial x^r}{\partial \tilde{x}^i} \frac{\partial x^s}{\partial \tilde{x}^j} \left[\frac{\delta}{\delta x^r}, \frac{\delta}{\delta x^s} \right],$$

so $\tilde{R}_{ij}^m = \frac{\partial x^r}{\partial \tilde{x}^i} \frac{\partial x^s}{\partial \tilde{x}^j} \frac{\partial \tilde{x}^m}{\partial x^n} R_{rs}^n$ and R is well defined.

Lemma 6.2. *The 0-homogeneous functions R_{ijk}^m satisfy*

$$0 = R_{ijk}^m + R_{jki}^m + R_{kij}^m, \quad (44)$$

$$R_{ijk}^m = -R_{ikj}^m, \quad (45)$$

$$R_{ijk}^m = \frac{\delta G_{ik}^m}{\delta x^j} - \frac{\delta G_{ij}^m}{\delta x^k} + G_{ik}^s G_{js}^m - G_{ij}^s G_{ks}^m. \quad (46)$$

Proof. Equation (45) follows from the definition, equation (46) follows from

$$R_{jk}^m = \frac{\partial N_k^m}{\partial x^j} - N_j^s G_{sk}^m - \left(\frac{\partial N_j^m}{\partial x^k} - N_k^s G_{sj}^m \right),$$

and equation (44) follows from equation (46). □

7 Symplectic geometry

Next we show that $T^*M \setminus \{0\}$ and $TM \setminus \{0\}$ are symplectic manifolds, and study geodesics and the Legendre transformation in this symplectic setting.

Definition 7.1. Suppose ω is a 2-form on a manifold M . Then ω is *non-degenerate*, if for each $x \in M$, we have the implication: If $a \in T_x M$, and $\omega_x(a, b) = 0$ for all $b \in T_x M$, then $a = 0$.

Definition 7.2 (Symplectic manifold). Let M be an even dimensional manifold, and let ω be a closed non-degenerate 2-form on M . Then (M, ω) is a *symplectic manifold*, and ω is a *symplectic form* for M .

Definition 7.3 (Hamiltonian vector field). Suppose (M, ω) is a symplectic manifold, and suppose H be a function $H: M \rightarrow \mathbb{R}$. Then the *Hamiltonian vector field* induced by H is the unique (see next paragraph) vector field $X_H \in \mathfrak{X}(M)$ determined by the condition $dH = \iota_{X_H} \omega$.

In the above, ι is the *contraction mapping* $\iota_X: \Omega^r M \rightarrow \Omega^{r-1} M$ defined by $(\iota_X \omega)(\cdot) = \omega(X, \cdot)$. To see that X_H is well defined, let us consider the mapping $X \mapsto \omega(X, \cdot)$. By non-degeneracy, it is injective, and by the rank-nullity theorem, it is surjective, so the Hamiltonian vector field X_H is uniquely determined.

Proposition 7.4 (Conservation of energy). Suppose (M, ω) is a symplectic manifold, X_H is the Hamiltonian vector field $X_H \in \mathfrak{X}(M)$ corresponding to a function $H: M \rightarrow \mathbb{R}$, and $c: I \rightarrow M$ is an integral curve of X_H . Then

$$H \circ c = \text{constant}.$$

Proof. Let $t \in I$. Since c is an integral curve, we have $(Dc)(t, 1) = (X_H \circ c)(t)$, so for $\tau = (t, 1) \in T_t I$, we have

$$\begin{aligned} d(H \circ c)_t(\tau) &= (c^* dH)_t(\tau) \\ &= (dH)_{c(t)}((Dc)(\tau)) \\ &= (dH)_{c(t)}((X_H \circ c)(t)) \\ &= 0, \end{aligned}$$

since ω is antisymmetric. The claim follows since $d(H \circ c)$ is linear. \square

Definition 7.5 (Symplectic mapping). Suppose (M, ω) and (N, η) are symplectic manifolds of the same dimension, and f is a diffeomorphism $\Phi: M \rightarrow N$. Then Φ is a *symplectic mapping* if $\Phi^* \eta = \omega$.

Proposition 7.6. Suppose (M, ω) is a symplectic manifold, and X_H is a Hamiltonian vector field corresponding to a function $H: M \rightarrow \mathbb{R}$. Furthermore, suppose $\Phi: I \times U \rightarrow M$ is the local flow of X_H defined in some open

$U \subset M$ and open interval I containing 0. Then for all $x \in U$, $t \in I$, we have

$$(\Phi_t^* \omega)_x = \omega_x,$$

where $\Phi_t = \Phi(t, \cdot)$.

Proof. As $\Phi_0 = \text{id}_M$, we know that the relation holds, when $t = 0$. Therefore, let us fix $x \in U$, $a, b \in T_x M$, and consider the function $r(t) = (\Phi_t^* \omega)_x(a, b)$ with $t \in I$. Then

$$\begin{aligned} r'(t) &= \left. \frac{d}{ds} [r(s+t)] \right|_{s=0} \\ &= \left. \frac{d}{ds} [(\Phi_s^* \omega)_y(a', b')] \right|_{s=0} \\ &= (\mathcal{L}_{X_H} \omega)_y(a', b'), \end{aligned}$$

where $y = \Phi_t(x)$, $a' = (D\Phi_t)(a)$, $b' = (D\Phi_t)(b)$, and the last line is the definition of the Lie derivative. Using Cartan's formula, $\mathcal{L}_X = \iota_X \circ d + d \circ \iota_X$, we have

$$\begin{aligned} \mathcal{L}_{X_H} \omega &= \iota_{X_H} d\omega + d\iota_{X_H} \omega \\ &= \iota_{X_H} 0 + ddH \\ &= 0, \end{aligned}$$

so $r'(t) = 0$, and $r(t) = r(0) = \omega_x(a, b)$. \square

Suppose M, N are manifolds, $\Psi: M \rightarrow N$ is a diffeomorphism. Then the pullback of Ψ for vector fields is the mapping

$$\begin{aligned} \Psi^*: \mathfrak{X}(N) &\rightarrow \mathfrak{X}(M), \\ Y &\mapsto (D\Psi^{-1}) \circ Y \circ \Psi. \end{aligned}$$

Proposition 7.7. *Suppose (M, ω) , (N, η) are symplectic manifolds, $\Phi: M \rightarrow N$ is a symplectic mapping such that $\Phi^* \eta = \omega$, and $h: N \rightarrow \mathbb{R}$ is a smooth function. Then*

$$\Phi^*(X_h) = X_{h \circ \Phi}.$$

What is more, if $c: I \rightarrow N$ is an integral curve of $X_h \in \mathfrak{X}(N)$, then $\Phi^{-1} \circ c$ is an integral curve of $X_{h \circ \Phi}$.

Proof. The contraction operator satisfies

$$\iota_{\Phi^* X} (\Phi^* \eta) = \Phi^* (\iota_X \eta)$$

for all $\eta \in \Omega^k(N)$, $X \in \mathfrak{X}(N)$. Thus,

$$\begin{aligned} \iota_{\Phi^* X_h} \omega &= \Phi^* (\iota_{X_h} \eta) \\ &= \Phi^* (dh) \\ &= d(h \circ \Phi) \\ &= \iota_{X_{h \circ \Phi}} \omega, \end{aligned}$$

and as ω is non-degenerate, $\Phi^* X_h = X_{h \circ \Phi}$. In consequence,

$$D(\Phi^{-1} \circ c) = D\Phi^{-1} \circ X_h \circ c = (\Phi^* X_h)(\Phi^{-1} \circ c) = X_{h \circ \Phi}(\Phi^{-1} \circ c),$$

so $\Phi^{-1} \circ c$ is an integral curve of $X_{h \circ \Phi}$. \square

7.1 Symplectic structure on $T^*M \setminus \{0\}$

For any manifold its cotangent bundle is a symplectic manifold.

Definition 7.8 (Poincaré 1-form). Suppose M is an manifold. Then the Poincaré 1-form $\theta \in \Omega^1(T^*M \setminus \{0\})$ is defined as

$$\theta = -\xi_i dx^i.$$

where (x^i, ξ_i) are local coordinates for $T^*M \setminus \{0\}$.

If $(\tilde{x}^i, \tilde{\xi}_i)$ are other standard coordinates for $T^*M \setminus \{0\}$, then $\xi_i = \frac{\partial \tilde{x}^r}{\partial x^i} \tilde{\xi}_r$, and $\xi_i dx^i = \frac{\partial \tilde{x}^r}{\partial x^i} \tilde{\xi}_r \frac{\partial x^i}{\partial \tilde{x}^l} d\tilde{x}^l = \tilde{\xi}_i d\tilde{x}^i$. Hence θ is well defined.

Lemma 7.9 (Coordinate independent expression for θ). Let π be the canonical projection $\pi : T^*M \rightarrow M$. Then the Poincaré 1-form $\theta \in \Omega^1(T^*M)$ satisfies

$$\theta_\xi(v) = \xi((D\pi)(v))$$

for $\xi \in T^*Q$ and $v \in T_\xi(T^*Q)$.

Proof. Let (x^i, y_i) be standard coordinates for T^*Q near ξ . Then we can write $\xi = \xi_i dx^i|_{\pi(\xi)}$ and $v = \alpha^i \frac{\partial}{\partial x^i}|_\xi + \beta^i \frac{\partial}{\partial y_i}|_\xi$, Thus $(D\pi)(v) = \alpha^i \frac{\partial}{\partial x^i}|_{\pi(\xi)}$, and $\theta_\xi(v) = y_i(\xi) dx^i|_\xi(v) = \xi_i \alpha^i = \xi((D\pi)(\alpha))$. \square

Proposition 7.10. The cotangent bundle $T^*M \setminus \{0\}$ of manifold M is a symplectic manifold with a symplectic form ω given by

$$\omega = d\theta = dx^i \wedge d\xi_i,$$

where θ is the Poincaré 1-form $\theta \in \Omega^1(T^*M \setminus \{0\})$.

Proof. It is clear that ω is closed. If $X = a^i \frac{\partial}{\partial x^i} + b^i \frac{\partial}{\partial \xi_i}$, and $Y = v^i \frac{\partial}{\partial x^i} + w^i \frac{\partial}{\partial \xi_i}$, then $\omega(X, Y) = a \cdot w - b \cdot v$. By setting $v = w$ we obtain $a = b$, and by setting $w = 0$ we obtain $a = b = 0$. \square

The next example shows that we can always formulate Hamilton's equations on the cotangent bundle. This motivates the name for X_H .

Example 7.11 (Hamilton's equations). Suppose M is a manifold, H is a function $T^*M \rightarrow \mathbb{R}$, and $X_H \in \mathfrak{X}(T^*M \setminus \{0\})$ is the corresponding Hamiltonian vector field. If (x^i, ξ_i) are standard coordinates for $T^*M \setminus \{0\}$, then

$$X_H = \frac{\partial H}{\partial \xi_i} \frac{\partial}{\partial x^i} - \frac{\partial H}{\partial x^i} \frac{\partial}{\partial \xi_i}.$$

Suppose that $\gamma: I \rightarrow T^*M \setminus \{0\}$ is an integral curve to X_H and locally $\gamma = (c, p)$. Then

$$\begin{aligned} \frac{dc^i}{dt} &= \frac{\partial H}{\partial \xi_i} \circ \gamma, \\ \frac{dp_i}{dt} &= -\frac{\partial H}{\partial x^i} \circ \gamma, \end{aligned}$$

that is, integral curves of X_H are solutions to Hamilton's equations in local coordinates of T^*M .

7.2 Symplectic structure on $TM \setminus \{0\}$

The previous section shows that $T^*M \setminus \{0\}$ is always a symplectic manifold. No such canonical symplectic structure is known for the tangent bundle. However, if M is a Finsler manifold, then $TM \setminus \{0\}$ has a canonical symplectic structure induced by the Hilbert 1-form on $TM \setminus \{0\}$.

Definition 7.12 (Hilbert 1-form). Let F be a Finsler norm on M . Then the Hilbert 1-form $\eta \in \Omega^1(TM \setminus \{0\})$ is defined as

$$\eta|_y = -g_{ij}(y)y^i dx^j|_y, \quad y \in TM \setminus \{0\}.$$

The next proposition shows that η is globally defined.

Proposition 7.13. *If $\mathcal{L}: TM \rightarrow T^*M$ is the Legendre transformation induced by a Finsler norm, then*

$$\mathcal{L}^*\theta = \eta,$$

*$d\eta$ is a symplectic form for $TM \setminus \{0\}$, and $\mathcal{L}: TM \setminus \{0\} \rightarrow T^*M \setminus \{0\}$ is a symplectic mapping.*

Proof. The first claim follows directly from the definitions by expanding the left hand side. Since $d\theta$ is non-degenerate, it follows that $d\eta$ is non-degenerate. \square

The next proposition shows that \mathbb{G} is globally defined.

Proposition 7.14. *In a Finsler space (M, F) , the Hilbert 1-form η and the geodesic spray \mathbb{G} satisfy*

$$d\eta(\mathbb{G}, \cdot) = d\left(\frac{1}{2}F^2\right),$$

so $X_{\frac{1}{2}F^2} = \mathbb{G}$. What is more, $X_F = \mathbb{G}/F$.

Proof. Using

$$d\eta = -\frac{\partial g_{ij}}{\partial x^r} y^i dx^r \wedge dx^j + g_{ij} dx^i \wedge dy^j,$$

we obtain

$$\begin{aligned} d\eta(\mathbb{G}, \cdot) &= \left(\left(\frac{\partial g_{ij}}{\partial x^s} - \frac{\partial g_{is}}{\partial x^j} \right) y^i y^j + 2g_{is} G^i \right) dx^s + \frac{1}{2} \frac{\partial F^2}{\partial y^i} dy^i \\ &= \frac{1}{2} \frac{\partial F^2}{\partial x^i} dx^i + \frac{1}{2} \frac{\partial F^2}{\partial y^i} dy^i. \end{aligned}$$

The second claim follows since $\iota_{X_F} \omega = dF = \frac{1}{F} d\left(\frac{1}{2}F^2\right) = \frac{1}{F} \iota_{\mathbb{G}} \omega = \iota_{\mathbb{G}/F} \omega$. \square

Propositions 7.6 and 7.14 state that $d\eta$ is preserved under the flow of \mathbb{G} . Another invariance property is the following:

Proposition 7.15. *F is a constant on integral curves of \mathbb{G} and \mathbb{G}/F .*

Proof. If c is in integral curve of \mathbb{G} , and \mathcal{L} is the symplectic mapping induced by F , then $\mathcal{L} \circ c$ is an integral curve of $X_{\frac{1}{2}F^2 \circ \mathcal{L}^{-1}}$. Proposition 7.4 implies that $F^2 \circ \mathcal{L}^{-1} \circ \mathcal{L} \circ c$ is constant. The proof of the second claim is analogous. \square

Now we can prove the converse of Proposition 3.9.

Proposition 7.16. *A stationary curve of E is a geodesic.*

Proof. Suppose E is stationary for a curve c . Proposition 3.6 implies that \hat{c} is a integral curve of \mathbb{G} . Hence, by Proposition 7.15, $F \circ \hat{c}$ is constant, and the result follows using Lemma 3.4. \square

The next proposition is analogous to Proposition 3.8.

Proposition 7.17. *If $\gamma: I \rightarrow TM \setminus \{0\}$ is an integral curve of \mathbb{G}/F , then $\pi \circ \gamma$ is a stationary curve for E . Conversely, if c is a stationary curve for E , then $\lambda = F \circ \hat{c}$ is constant and $c \circ \widehat{M_{1/\lambda}}$ (see below) is an integral curve of \mathbb{G}/F .*

If $s > 0$, we denote by M_s the mapping $M_s: t \mapsto st, t \in \mathbb{R}$.

Proof. Let $c: I \rightarrow TM \setminus \{0\}$ be an integral curve of \mathbb{G}/F . If $c = (x, y)$, then

$$\begin{aligned}\frac{dx^i}{dt} &= \frac{y^i}{\lambda}, \\ \frac{dy^i}{dt} &= -2\frac{G^i \circ c}{\lambda},\end{aligned}$$

where $\lambda = F \circ \gamma > 0$ is constant. The first equation implies that $c = \lambda \widehat{\pi \circ \gamma}$. Since G^i is 2-homogeneous, it follows that

$$\frac{d^2 x^i}{dt^2} + 2G^i(\widehat{\pi \circ c}) = 0,$$

so $\pi \circ c$ is a stationary curve for E . Conversely, if $c: I \rightarrow M$ is a stationary curve for E , then $\lambda = F \circ \hat{c}$ is constant, and $c \circ M_{1/\lambda}$ is also a stationary curve for E . Then $\gamma = \widehat{c \circ M_{1/\lambda}}$ is an integral curve of \mathbb{G} , and since $F \circ \gamma = 1$, γ is an integral curve of \mathbb{G}/F . \square

The next proposition shows how the Hamilton equations can be formulated using the Legendre transformation and Finsler quantities on the tangent bundle.

Proposition 7.18. *Suppose $h: T^*M \rightarrow \mathbb{R}$ is a co-Finsler norm, $\mathcal{L}: T^*M \rightarrow TM$ is the induced symplectic mapping, and \mathbb{G} is the geodesic spray induced by the Finsler norm $F = h \circ \mathcal{L}^{-1}$. If γ is an integral curve of X_h , and $\lambda = h \circ \gamma > 0$, then*

$$\lambda \widehat{\pi \circ \gamma} = \mathcal{L} \circ \gamma. \quad (47)$$

A curve $\gamma = (c, p): I \rightarrow T^*M \setminus \{0\}$ is an integral curve to X_h if and only if

$$\frac{dc^i}{dt} = \frac{1}{\lambda} y^i \circ \mathcal{L} \circ \gamma, \quad (48)$$

$$\frac{dp_i}{dt} = \frac{1}{\lambda} (N_i^m \mathcal{L}_m^{-1}) \circ \mathcal{L} \circ \gamma. \quad (49)$$

Proof. Equations (48)-(49) follow from Example 7.11 and equation (43). Equation (47) follows from equation (48). \square

The next proposition shows how stationary curves of E are transformed under the Legendre transformation.

Proposition 7.19. *Suppose $h, \mathcal{L}, \mathbb{G}$, and F are as in Proposition 7.18, and π is the canonical projection $\pi: T^*M \rightarrow M$.*

1. *If $\gamma: I \rightarrow T^*M \setminus \{0\}$ is an integral curve of X_h , then $\pi \circ \gamma$ is a stationary curve for E .*

2. If $c: I \rightarrow M$ is a stationary curve for E , then $\lambda = F \circ \hat{c}$ is constant and $\mathcal{L}^{-1} \circ c \circ \widehat{M_{1/\lambda}}$ is an integral curve of X_h .

Proof. In the first claim, $\mathcal{L} \circ \gamma$ is an integral curve of X_F . Since $X_F = \mathbb{G}/F$, the result follows from Proposition 7.17. The other proof is similar. \square
